There are **NO FEES** for the Farmers' Market.

**MARKET SCHEDULE:** Tuesdays, 9:00 am – 1:00 pm, June 22 through September 28, 2010.

**MARKET LOCATION:** Pick 'n Save parking lot on the 700 block of South Central Avenue (across from City Hall).

**VENDOR REGISTRATION:** To participate with a reserved spot, the Vendor Registration Form (enclosed) must be received by Monday of the week of the desired market. Please reserve in advance as space is sometimes limited. Additional applications are available on-site, but a space cannot be guaranteed unless the Main Street office receives an application by the Monday prior to the market date.

**ALLOWABLE SALE ITEMS:** The market will cater to high quality homegrown products. The following list may be expanded at the discretion of the Main Street Farmers' Market Governing Board:

**PRODUCE** – Fresh or dried fruits, herbs, vegetables, nuts, berries, sprouts or grains.

**MISCELLANEOUS** – Flowers, bouquets, unprocessed honey, maple products, eggs, fresh or frozen meats, poultry, baked goods, preserves and crafts. **Note:** Eggs, fresh meats or poultry must be kept cold at all times.

**UNALLOWABLE SALE ITEMS:** Processed foods such as pickles, pesto, salsa, dressing and tomato products cannot be sold at the market. No garage sale or rummage sale items are allowed. No beverages for individual on-site consumption may be sold.

We will have a food stand on-site to provide snacks, beverages and lunches.

**NO ALCOHOLIC BEVERAGES ARE ALLOWED ON THE MARKET SITE FOR SALE OR CONSUMPTION. NO PETS OR ANIMALS ARE ALLOWED ON THE MARKET SITE WITH THE EXCEPTION OF SEEING EYE DOGS. PLEASE DO NOT ALLOW CHILDREN TO ROAM THE MARKET SITE WITHOUT ADULT SUPERVISION. ALL PROBLEMS AND CONFLICTS SHOULD BE DIRECTED TO THE MARKET SUPERVISOR WHO WILL HAVE THE FINAL SAY IN CONFLICTS OR DISPUTES.**
